Open to any dart player from an approved SD Pool and Dart Tournament Corporation sanctioned league under the age of 21 at the time of the event. If their birthday is July 27th the thrower would be only eligible to participate on Friday, July 26th, 2024. Tournament Director reserves the right to refuse admittance or to remove any player in any or all situations.

- All throwers must be:
- 1) Sanctioned by the NDA
 - 2) have 30 games in no less than 6 weeks of league play
 - 3) If the thrower does not have Cricket Stats '01 stats will be converted for Cricket Events



League games must be played between August 1st, 2023 and June 14th, 2024. Signups will need to be completed by deadline in all events with one exception, on site signups will be allowed for the Saturday Night Social Draw Doubles Event. No other signups will be allowed on site. All events have a \$20 Entry Fee + \$3 Admin fee + \$7 board fee = \$30 per player per event. With the exception of triples - where it is a \$75 entry fee, the boards fees and admin fee are combined. Boards will be set on unlimited play because of the board fees. Compusport and League Leader will be utilized at this event. **The NDA Rulebook will be in effect except for rules specifically addressed in the 2024 South Dakota State Jr Tournament Handbook including the Dress Code and pets/animals.
